## TERMS AND CONDITIONS:

### Dacorum Crew, Facilities & Locations Database (“the Database”)

#### 1. TERMS OF USE

This document states the terms of use on which you may use the Database (the “Terms”). Please read these Terms carefully before you start using the Database. By using the Database, you confirm that you accept these Terms and that you agree to comply with them. If you do not agree to these Terms, you must not use the Database.

#### 2. INFORMATION ABOUT US

The Database is hosted by [Dacorum : Location Registration from MovieSite \(openbrolly.com\)](http://openbrolly.com) which is a site operated by Dacorum Film Office at Dacorum Borough Council (“we” or “us”). Dacorum Film Office is operated by Dacorum Borough Council, The Forum, The Marlowes, Hemel Hempstead, HP1 1DN

#### 3. ACCESSING OUR DATABASES

Access to the Database is permitted on a temporary basis, and we reserve the right to withdraw or amend the Database without notice. We will not be liable if for any reason the Database is unavailable at any time or for any period. From time to time, we may restrict access to some parts of the Database, or the entire Database, to users who have registered with us. If you choose, or you are provided with, a user identification code, password, or any other piece of information as part of our security procedures, you must treat such information as confidential, and you must not disclose it to any third party. We have the right to disable any user identification code or password, whether chosen by you or allocated by us, at any time, if in our opinion you have failed to comply with any of the provisions of these Terms.

You are responsible for ensuring that all persons who access our site through your internet connection are aware of the Terms and that they comply with them.

#### 4. GETTING LISTED ON THE DATABASE

Crew, production/facility companies or locations based in the borough of Dacorum are eligible to list themselves on the Database. We are responsible for deciding if you are eligible to list yourself on the Database and reserve the right to refuse any application for a listing. In order to be eligible you must:-

- 4.1 be a homeowner or a tenant with permission from your landlord to list the property; and

- 4.2 the property must be within the borough of Dacorum;
- 4.3 any other criteria as may be specified from time to time

You must complete your registration details as accurately as possible and you are responsible for keeping your details up to date. If we become aware any of the information you have submitted on the Database is inaccurate, we reserve the right to remove your listing with immediate effect.

## **5. CONTENT OF LISTINGS AND POSTINGS**

Any content you upload to our site will be considered non-confidential and non-proprietary. You retain all of your ownership rights in your content, but you are required to grant us and other users of our site a limited licence to use, store and copy that content and to distribute and make it available to third parties

You may not post anything on the Database that we consider to be offensive, obscene, threatening, harassing or defamatory or otherwise unlawful. In particular, you must not use the Database for any illegal or unlawful purpose, including posting anything that is fraudulent, inaccurate, incomplete, false or misleading. You must not impersonate any person, group company or entity. In the event that we are made aware of any such posting we reserve the right to remove your listing with immediate effect. By uploading any content to the Database, you are confirming that you own the copyright to it . If we become aware that you do not own copyright to any such content that you have loaded , we reserve the right to remove any such content with immediate effect.

## **6. INTELLECTUAL PROPERTY RIGHTS**

We are the owner or the licensee of all intellectual property rights in the Database, and in the material published on it. The Database is protected by intellectual property laws and treaties around the world. All such rights are reserved.

You grant us a perpetual, irrevocable, royalty-free license to reproduce your listing on the Database. You warrant and represent that you have the right to grant such a license.

You may print off one copy, and may download extracts, of any page(s) from the Database for your personal reference and you may draw the attention of others within your organisation to material listed on the Database.

You must not use any part of the materials on the Database for commercial purposes without obtaining a license to do so from us or our licensors.

If you print off, copy, or download any part of the Database in breach of these Terms, your right to use the Database will cease immediately and you must, at our option, return or destroy any copies of the materials you have made.

You must not engage in automated or manual harvesting of data or any other

collecting of information from the Database for any purposes that are not related to our key activity of supporting the creative industries in England. We reserve the right to take legal action against any party found to be collecting, storing, or using the information contained within the Database outside of these Terms.

## **7. RELIANCE ON INFORMATION POSTED**

Information listed on the Database is not intended to amount to advice or an endorsement on which reliance should be placed. We therefore disclaim all liability and responsibility arising from any reliance placed on such materials by any user of the Database, or by anyone who may be informed of any of its contents.

We do not endorse or recommend any specific listing on the Database and you acknowledge that we are not liable for your dealings with anyone who has a listing on the Database. It is your responsibility to check the accuracy of the information of companies and individuals whose information is listed on the Database before you place reliance upon it.

## **8. OUR SITE CHANGES REGULARLY**

We aim to update our site regularly and may change the content at any time. If the need arises, we may suspend access to our site, or close it indefinitely. Any of the material on our site may be out of date at any given time, and we are under no obligation to update such material.

## **9. LIABILITY**

We reserve the right to use your information for what we consider to be marketing purposes relevant to the television and film production companies. You expressly consent to us including your email address and other contact details in our mailing lists. If at any time you object to the use of your information in this way, you should contact us at [filming@dacorum.gov.uk](mailto:filming@dacorum.gov.uk) stating the information you want to be removed. Specifically, we may use the personal data you submit to the Database for invitations to our events, co-hosted events or any regional or national events that we feel are suitable and/or of interest to entities who have provided information to the Database.

From time to time, we may use generalised statistical data for reporting purposes to external agencies – for example, a regional breakdown of crew in terms of gender, location, age etc.

We may also commission research for the purposes of strategic development and access to the Database may be granted to approved third parties for this purpose. Contact details for registered crew, facilities and production companies will be made available to production companies and individuals who have registered through [Openbrolly](#) to search the Database. We reserve the right to verify such companies or individuals before their ability to search is approved.

We process information about you in accordance with our [privacy policy](#). By using our site, you consent to such processing and you warrant that all data provided by you is accurate.

## **11. UPLOADING MATERIAL TO THE DATABASE**

Any material you upload to the Database will be considered non-confidential and non-proprietary, and we have the right to use, copy, distribute and disclose to third parties any such material for any purpose. We also have the right to disclose your identity to any third party who is claiming that any material posted or uploaded by you to the Database constitutes a violation of their intellectual property rights, or of their right to privacy. We will not be responsible, or liable to any third party, for the content or accuracy of any materials posted by you or any other user of the Database. You are responsible for the content or accuracy of any materials posted by you or any other user of the Database and you agree to indemnify us in respect of any losses, expenses, damages, and costs, including any legal fees resulting from: any breach by you of these Terms; any infringement of copyright or other intellectual property rights in material posted by you; or any other wrongful use of the service.

## **12. VIRUSES, HACKING AND OTHER OFFENCES**
